

**DECLARATION OF AWARENESS OF RISK-TAKING AND DISCLAIMER OF LIABILITY**

**BREVET: Super Randonnée dei Cento Bersaglieri**

Require to be registered for the **Brevet Super Randonnée dei Cento Bersaglieri**, departing and arriving in the province of Verona. The brevet is organised by **Sport Verona ASD** and the homologation is managed by **ARI Audax Italia**.

For this purpose **I self-certify and declare as follows, assuming all liability, both civil and criminal, in the event of a reckless, irresponsible and/or false declaration:**

- To have read and carefully evaluated the description of the Super Randonnée dei Cento Bersaglieri on the relative web page and consequently to know, as far as possible, the route, the altimetries, the difficulties and the dangers.
- To have carefully read, to have understood and to accept in all its parts the Rules of the Super Randonnée dei Cento Bersaglieri (only in Italian language), visible and downloadable in the event web page, mentioned above.
- To be fully aware of the risks to my and others' safety, implied in participating in the randonnée in conditions of total self-sufficiency, as it is an individual excursion.
- To have considered to have enough personal experience and psycho-physical ability to be able to manage autonomously the difficulties I may face due to possible adverse and severe weather conditions, even at night.
- To assume the following risks: difficulty in finding water, food or a place where to shelter or to rest (even just for a few hours), night cycling, the possible presence of animals on the route, orientation problems, physical and mental fatigue, ailments, injuries, the risk of being injured and/or incapacitated in a place where medical assistance may not be possible in time to avoid physical damage, even fatal.
- To be aware of the absence of any technical support or assistance (including health assistance) during the event, and that the passage from the check-points on the route - not manned - have the sole function of allowing the organiser to verify the compliance with the route, in order to approve the brevet. In case of withdrawal, I will have to autonomously organise my and my bike return and inform the organiser as soon as possible.
- To have checked if bike and all its components are in optimum conditions, especially the braking system and the adequate night lighting devices, and to be solely responsible of their proper functioning.
- To exempt the Organizer from any obligation of permanent and/or current control of the route, due to its particular length.
- To allow the Organizer the free use of still or moving images portraying me on the occasion of the Randonnée, without territorial and time limits.
- To acknowledge that the only legal obligation assumed by the Organizer towards me is to assess if I correctly completed the Randonnée, in order to obtain the approval of the Brevet by Audax Club Parisien.
- To acknowledge that no liability, nor contractual or non-contractual, can be ascribed to the Organiser for any damages (even property damages), which I have suffered or caused to third parties during the Randonnée.
- To release the Organizer and its collaborators from any liability and burden, including any legal costs, for any damages, injuries, losses, suffered by me, my bike, my equipment or suffered by third parties and their things, due to my conduct, in relation to my participation during the Brevet, whatever the cause is.
- To comply with the Traffic Code and to always maintain the appropriate bicycle conditions according to the Traffic Code, in particular as regards the braking and lighting systems.
- To acknowledge the obligation to wear the regularly approved rigid protective helmet during the entire duration of the Randonnée, and to immediately report to the Organisation about my withdrawal or delay. In case of absence of notification, police forces will be alerted: any costs and responsibilities are to my charge.
